

ispose of household items - including furniture, electronics and appliances - at the Township during the Annual Tom King Memorial Junk Day.

This is a free program to Bath Charter Township residents. Space is limited and registration is required to participate. There is a 2-load limit per address – a truck or trailer load equates to one load.

If authorized items are mixed with unauthorized items in your load, our crews are not obligated to sort the materials and may refuse the entire load.

CURBSIDE SERVICE FOR RESIDENTS 60+ AND/OR DISABLED

The Township will also provide a curbside-only service for citizens age 60+, or individuals who are physically disabled and can't drop-off site.

Items must be placed curbside by 8 am on the day of your scheduled pick up. Crews will not enter your property to collect items. If you need help placing items curbside, there may be assistance available through Unity in the Community, a Bath High School program. If authorized items placed for collection are mixed with unauthorized items, our crews are not obligated to sort the

materials and may refuse the entire load.

Qualified persons may call the Township Offices at (517) 641-6728 beginning on April 20 to schedule a pick-up appointment for the week of May 4.

Keeping the Township Orderly & Neat

aintaining healthful surroundings for life in agricultural, residential and non-residential areas is attainable through the efforts of the entire community.

If you have any of the following located on your property outside of a completely enclosed building, you could potentially be in violation of the Township's Code of Ordinances:

TRASH & RUBBISH

Any and all forms of debris not otherwise classified.

JUNK

Includes parts of machinery or motor vehicles, broken and unusable furniture, stoves, refrigerators and other appliances, remnants of wood, metal or any other cast off material of any kind, whether or not the material could be put to any reasonable use.

JUNK VEHICLES

Any wrecked or dismantled vehicle, including, but not limited to, cars, trucks, tractor trucks and trailers, utility trailers, mobile homes,

recreation vehicles (motorcycles, boats, travel trailers, motor homes, campers, all-terrain vehicles, snowmobiles and trailers), and other similar vehicles which are not licensed for use upon highways of the State and shall also include, whether licensed or not, any vehicle which is inoperable or does not have all of its main component parts attached.

BUILDING MATERIALS

Includes lumber, bricks, concrete or cinder blocks, plumbing materials, electrical wiring or equipment, heating ducts, equipment, shingles, mortar, concrete or cement, nails, screws or any other materials used in constructing any structure.

The Township will again be hosting the Annual Tom King Memorial Junk Day on May 9, 2015 which allows residents to dispose of many types of items at no or minimal charge.

Clinton County Tornado Siren Testing Central Dispatch does not send out "all clear"

pring is here and the threat of a severe storm comes with the season. All tornado sirens within Clinton County are activated by Clinton County Central Dispatch.

Central Dispatch will be conducting monthly testing of all in-county tornado sirens at noon on the first Saturday of each month, April through October. The test will not be completed if inclement or stormy weather is in the area. Tornado siren testing consists of a 1-minute blast or cycle and then the deactivation tone is sent.

An actual tornado warning will have the siren sounding a solid tone for a full three minutes. If you hear this three minute solid tone, you are to seek immediate shelter.

Central Dispatch does not send out "all clear" tones. You should listen to your local radio or TV for the status of the storm in your area.

In Bath, four tornado sirens are activated by Central Dispatch simultaneously with DeWitt and Eagle sirens. Bath Township tornado sirens are located at James Couzens Park near Main Street, Park Lake Road and Webster Road, Austin Way and Coleman Road, and Upton Road and M-78 (mobile home park).

911 in Clinton County

Il residents in Bath Township should be aware that in Clinton County, and only in Clinton County, 911 is for emergency and non-emergency calls. In order to get a non-emergency call to Central Dispatch you still need to dial 911. This procedure is designed to simplify calls for service in Clinton County. Some people feel that they are tying up a 911 line. In our county the dispatcher will quickly ascertain whether a true emergency exists. If your call is not an emergency and another call is an emergency, they will put you on hold and deal with the emergency call first.

Road Proposal on May 5, 2015 Ballot

n May 5, 2015, citizens will have the opportunity to vote on Proposal 2015-1, a statewide ballot proposal aimed at road construction and maintenance. Currently, under Michigan's Constitution, sales taxes paid at the pump on gasoline and diesel go primarily to schools and local governments, not roads. Passage of Proposal 2015-1 would change this dynamic by (a) removing three taxes on fuel-the current 6% sales tax on gasoline and diesel, the additional 19-cent/gallon tax on gasoline, and the additional 15-cent/gallon tax on diesel, (b) replacing all of those taxes with a flat 14.9% wholesale tax paid directly by gas and diesel stations, (c) increasing certain vehicle registration fees, and (d) dedicating all the revenues from the wholesale tax on fuel and registration fees to transportation. If passed, Proposal 2015-1 is expected to generate \$1.2 billion annually for road construction and maintenance and \$116

million annually for public transportation.

To replace the revenues to schools and local governments lost by dedicating taxes paid at the fuel pump to transportation, Proposal 2015-1 would increase the sales and use tax on non-fuel taxable items from 6% to 7%. If passed, this is expected to replace the lost revenues, as well as generate annually an additional \$200 million for schools, \$111 million for local governments, and \$173 million of general fund revenues. Legislation tied to the proposal would provide tax relief to certain low- and middle-income taxpayers through the Earned Income Tax Credit.

Passage of Proposal 2015-1 would also require warranty protections, competitive bidding, and performance-based systems for road construction and maintenance projects.
