New Employees at the Township



Cemetery Rules & Regulations

Recently, there have been several cemetery rules and regulations that have not been properly followed. It is important for these rules to be followed in order for the Township to properly maintain our cemeteries and to avoid damage to flowers, decorations, and other items. **As a courtesy, the Township will allow any sites out of compliance to remove or rearrange items that do not meet the approved rules and regulations no later than July 22, 2021.** After this time, the Township reserves the right to remove, and dispose of, without notice to the owner, any unsightly, deteriorated, neglected, or prohibited items except monuments or markers.

- Artificial flowers or similar ornamentation shall not be placed on the ground between April 15 and October 15, both inclusive. Artificial flowers may be placed in an urn if they are properly secured.
- Grave blankets and other types of winter decorations shall not be placed before October 15 and shall be removed by April 15.
- Flowers may be planted only within twelve inches (12") of the front of the monument or marker. Under no circumstances will such planting be allowed outside the boundaries of the owner's burial space(s).
- Urns must be placed in line with the headstone or placed directly back of the headstone as close as possible.
- The use of glass, plastic or clay containers is prohibited.
- The use of stone, limestone, woodchips, etc. is prohibited.
- Structures of wood or other equally perishable materials, fences, curbs, hedges, and copings are prohibited.
- Chairs, settees, and benches on lots are prohibited.
- The planting of trees and shrubbery shall be done only after approval of cemetery staff as to species, variety, location, and time of planting.
- The Township assumes no responsibility for damage to markers or monuments whatsoever, including regular cemetery maintenance.

Township Updates

- Burn permits MUST be called into the burn permit phone line **no later than** 4 p.m. the day you wish to activate it. Permits that need to be activated for the weekend MUST be called in by 4 p.m. on Friday.
