A person will be disqualified and prohibited from serving a s a volunteer with Bath Charter Township programs if the person:

- 1. Fails to consent to a personal criminal background search (ICHAT); or,
- Has been convicted (including crimes whereby a plea of "no contest" was entered) of a crime of child abuse, sexual assault, child neglect, murder, voluntary manslaughter, felony assault, arson, robbery, burglary, indecent exposure, public lewdness, terrorist threats, any offense against a minor, kidnapping, or felony violations of the Controlled Substance Act; or,
- 3. Has been twice convicted, in any combination, of the following offenses: Misdemeanor Assault, violation of the Controlled Substance Act; or,
- 4. Has been twice convicted, in any combination during the past seven years of the following offenses: Driving While Intoxicated (DWI) or Driving Under Influence (DUI), or
- 5. Has been adjudged liable for civil penalties or damages involving sexual or physical abuse of children; or,

6. Has been subject of any court order involving any sexual abuse or physical abuse of a minor, including but not limited to domestic order for protection.

The Bath Charter Township administrative staff shall have the final decision on all personnel matters.
